

Ordinance **20-02**  
Tax Levy Ordinance  
Of the  
Shorewood-Troy Public Library District  
Will County, Illinois  
For Fiscal Year July 1, 2020 to June 30, 2021

AN ORDINANCE for the Assessment, Levy and Collection of taxes within the Corporate Limits for the general corporate purposes of the SHOREWOOD-TROY PUBLIC LIBRARY DISTRICT, WILL COUNTY, ILLINOIS, for the fiscal year commencing July 1, 2020 and ending June 30, 2021; for a special audit expense tax levy, for a special liability insurance expense tax levy, for a special municipal retirement expense tax levy, and for a special equipping and maintenance expense tax levy for said fiscal year. BE IT ORDAINED by the Board of Trustees of the SHOREWOOD-TROY PUBLIC LIBRARY DISTRICT, WILL COUNTY, ILLINOIS:

SECTION 1:

That there be, and hereby is, levied and assessed upon all taxable property both real and personal, within the Shorewood-Troy Public Library District, Will County, Illinois, and the same assessed and equalized for state and county purposes, taxes sufficient to produce the sum of \$1,248,406 of which sum is levied together with \$312,000 to be derived from other sources, being in the total amount appropriation legally made for general library purposes for said taxable year, which sum is to be used for, has been appropriated for purposes and the amount specified as follows, to wit:
